L. Consideration and action to approve the City Manager employment contract

Commissioner Pete Morales motioned to approve, and Mayor Pro-Tem Robert De La Garza seconded. Motion carried.

M. Consideration and action on a variance request to allow for a l'8" front setback instead of the code minimum 25' front setback, physically located at 429 Delia Ave., legally described as Lot 42, Alma Delia Subdivision for Jose Fernando Hernandez.

City Manager Robert Salinas stated this is an existing carport and applying for the front set back. Similar to past carports, this was presented to P&Z on February 19<sup>th</sup> and was approved.

Mayor Diana Martinez motion to approve, and Commissioner Pete Morales seconded. Motion carried.

N. Consideration and action on a variance request to allow the construction of a new home in anR-MH (Mobile Home and Modular Home District), physically located at 413 King James Drive, legally described as Lot 56, Royalty House Unit 3 for Alicia Maldonado.

City Manager Robert Salinas stated Ms. Alicia Maldonado came to our office stating she had been approved by the Urban County Rehabilitation Program and qualified for a new home, the applicant is proposing to demolish the existing home and construct a new single-family home. This was presented to P&Z on February 19<sup>th</sup> and was approved.

O. Consideration and action on a variance request to Title 10-Zoning Regulations; Chapter 3-General Zoning Provisions; Section 10-3-3(C), physically located at 804 Vida Santa St., legally described as Lot D, Tierra Encantada Subdivision for Rene Garza.

City Manager Robert Salinas stated this site is located approximately 175' north from Tierra Del Sol Ave. on the east side of Vida Santa St. He stated if you recall a similar item was approved to the west, the applicant would like to construct a 40' X 40' patio. This was presented to P&Z on February 19<sup>th</sup> and was approved.

P. Consideration and action on a conditional use permit for a mobile food vendor - Rocco's Roasted Corn, physically located at 1211 E. Frontage Rd., legally described as Alamo H.E.B. for Rogelio Maldonado.

City Manager Robert Salinas stated this is a common mobile food vendor in the front area of H-E-B, the last approval was circus popcorn.

- Hours of Operation: Monday-Sunday from 12:00 p.m. to 9:00 p.m.
- Staff: 2 employees
- Parking: In regards to parking spaces, the applicant will be utilizing the parking area for H.E.B.

Staff recommends a 1-year approval subject to:

- Compliance with the City's Building & Fire Codes,
- · Compliance with the County Health Codes, and
- Must acquire a Business License.
