Garza received a majority of votes cast to be elected Commissioner Place Three of the City of Alamo and shall commence his term of office upon execution and filing of the Oath of Office for Commissioner Place Three of the City of Alamo, Hidalgo County, Texas.*

*3. **Municipal Judge:** Celia Garcia received a majority of votes cast to be elected, however; a petition of recount has been requested. The recount will commence on November 10th at 9am.*

Commissioner Pete Morales motioned to approve, and Commissioner Robert De La Garza seconded. Motion carried.

Judge Luis Singleterry spoke on the victory of J.R. Garza and administered the oath of office for Commissioner Place 3 for the City of Alamo


Commissioner J.R. Garza recited his oath of office and thanked the community for their support and prayers.
