City Manager Robert Salinas responded yes, by December 2024. We do need it allocated for use for certain projects.

H. Consideration and Action to approve on the purchase of Raw Water from Hidalgo County Irrigation District No.2.

City Manager Robert Salinas stated The City of Alamo annually makes a purchase of Raw Water from the Hidalgo County Irrigation District No. 2. We usually purchase approximately 1,000 acre feet of water in order to ensure we have sufficient water until the end of the year. As the year progresses, we will see if there would need to be an additional purchase of water in order to finish out the year. The cost of the water is \$60/acft which would be a total of \$60,000 (\$60 X 1,000acft). Staff's Recommendation: Approve the purchase of 1,000acft of water from HCID No.2. This item is now before you.
