5. Discussion and Possible Action on a petition submitted by Abelardo Ordonez of 1235 Stensbo Street to have the City establish a 4-way Stop at Stensbo and N. 12<sup>th</sup> Street
6. Discussion and Possible Action on a petition by several owners of La Hacienda Estates to place a Speed Bump on Las Fuentes Dr.
7. Discussion and Possible Action on a request by Perfecto David Castillo of 701 Margret Street to have the City establish a 4-way Stop at Tower Road and Becker/Martinez; or dependent on TSC assessment, Staff may propose a 4-way Stop at Becker/Nebraska instead
8. Discussion and Possible Action on a request by Israel Vasquez of 713 Texana Lane to place a Speed Bump on Texana Lane in the Sable Palms Subdivision.
