### C. Presentation and Announcements

- Alamo Chamber of Commerce Executive Director Leticia Luna invited everyone to the Veteran's Memorial Park this upcoming Monday November 11<sup>th</sup> at 9 a.m., for a Veteran's Day Ceremony.
- Commissioner Pete Morales thanked Leticia Luna, the Alamo Chamber of Commerce and the City of Alamo Directors for their help and participation at the Trail of Terror at the Alamo Nature Park.
- Commissioner AJ Garcia thanked everyone who participated at the Alamo Trail of Terror event which was a huge success. He acknowledged City Manager Robert L. Salinas, and Assistant City Manager Alexandra Rangel for being scarers at the Trail of Terror as well as the other City of Alamo departments who participated.
- Mayor J.R. Garza congratulated our Library Supervisor Jessica Garcia for being selected as one of the 33 National Collaborators for the Collaborative Summer Library Program.

### III Regular Agenda

D. Presentation of Delinquent Tax Collection Report for the period of October 01, 2023 through September 30, 2024 presented by Linebarger Goggan Blair & Sampson, LLP (Jaime E. Gonzalez).

Linebarger Goggan Blair & Sampson, LLP Representative Jaime E. Gonzalez presented the Delinquent Tax Collection Report for the period of October 1, 2023 to September 30, 2004. Our delinquent tax collection program for the City of Alamo continues to emphasize two basic promises: to work with individual taxpayers to collect taxes owed to the city and to only use the tool of litigation as a final option. We listen and continually adapt to your changing needs to ensure that we are providing the best possible service and deliver customized collection programs that yield the best possible results. The following information is an overview of our collection's efforts during this reporting period.

- Top 25 Accounts
- Collections

Our office is committed to making necessary adjustments to our collection procedures and methods to best advocate for the City of Alamo. We will continue to offer firm yet flexible payment options for taxpayers experiencing financial hardship.

E. Consideration and Action to approve an emergency purchase of Raw Water from La Feria and Brownsville Irrigation District.

City Manager Robert L. Salinas stated that the City of Alamo has purchased Raw Water from La Feria and Brownsville Irrigation District Irrigation District. We purchased approximately 734 acre-feet of water in order to ensure we have sufficient water until the end of the year. As the year progresses, we will see if there would need to be an additional purchase of water. The cost of the water is \$75/ac ft which would be a total of \$22,500 – La Feria The cost of the water is \$80/ac ft which would be a total of \$34,720 – Brownsville Staff's Recommendation: Approve the purchase of 734-acre feet. The amount is over the \$15,000 threshold. This item is now before you.

Mayor Pro-Tem Okie Salinas asked if he noticed a change from last year.

City Manager Robert L. Salinas answered that the City of Alamo typically purchases around 1,000 acre-feet of water. This year however, we needed to acquire more due to a water meter issue, which led to penalties.

Commissioner AJ Garcia motioned to approve, Commissioner Roel Leon Moreno Jr. seconded. Motioned carried

F. Consideration and Action to Approve an Ordinance Amending the FY 2024-2025 General Fund Budget for October 1, 2024 to September 30, 2025.

City Manager Robert L. Salinas stated that both items F and G are similar ordinances that will be ratify due to changes of purchases that need to be made for example; the Welcome Sign Project, Remodeling for Fire Station # 1, etc.

Commissioner Roel Leon Moreno Jr. motioned to approve, Mayor Pro-Tem seconded. Motion carried.

G. Consideration and Action to Approve an Ordinance Amending the FY 2024-2025 Water and Sewer Fund Budget for October 1, 2024 to September 30, 2025.

Commissioner Roel Leon Moreno Jr. motioned to approve, Commissioner AJ Garcia seconded. Motion carried.

H. Discussion and Possible Action to Appoint or Re-appoint a Member to the Planning & Zoning Commission due to an expiring membership term.

Planning Department Sergio Zavala stated that in the Code of Ordinances, Section 2-2-2: Membership and Terms, provision (A) mandates that a member of the Planning & Zoning Commission must be a resident of the City of Alamo. Provision (B) reflects the mandate that the P&Z members' term will be for three (3) years and "may be reappointed by a majority vote of the Board of Commissioners ... ". With the above foundation, please be advised that Mr. Eleazar Escobedo was appointed on December 5, 2023 to the P&Z Commission (to replace Roel Moreno who was elected to the City Commission). Mr. Escobedo's PZ membership is set to expire on December 5, 2024; his attendance record is perfect at 100%, i.e., 8 out of 8 meetings. Mr. Escobedo was called to see if he'd be receptive in serving another term, if reappointed. She replied that she'd like to be re-appointed to continue serving on P&Z. This matter is now before you.

Commissioner Roel Leon Moreno Jr. motioned to appoint Eleazar Escobedo, Mayor Pro-Tem Okie Salinas seconded. Motioned carried.
