I. CALL MEETING TO ORDER

Mayor J.R. Garza called the special meeting held on Tuesday December 3rd, 2024 to order at 6:00 p.m. at the City of Alamo Municipal Building. City Manager Robert L. Salinas led the Pledge of Allegiance and Pastor Tuttle led the Invocation.

Presentation and Announcements

- Alamo Chamber of Commerce Executive Director Leticia Luna stated that they have presented the Alamo Chamber of Commerce Audit for 2023-2024. The Alamo Chamber of Commerce aims to boost revenue and implement innovative ideas, including a proposed tax rate increase, to support sustainable growth and strengthen the community's economic foundation.
- Assistant City Manager Alexandra Rangel invited everyone to our annual Christmas Parade and Tree Lighting this upcoming December 13th, 2024 from 6:30 to 9 p.m.. Starting at Alamo Road, turning east on old 83 and ending at Downtown Central Park.
- Commissioner AJ Garcia announced the Mighty Wolverine Band Color Guard Winter Concert on December 10th, 2024 at 6p.m. at the Robert Gomez Jr. Auditorium. This event is free admission.
- Commissioner Pete Morales congratulated all the City of Alamo employees who helped with all the Christmas Decorations.
- Commissioner Roel Leon Moreno Jr. stated that the City of Alamo employees will be participating in the City of Alamo Department Games on December 7th, 2024 starting at 10 a.m.
- AEDC Consultant Isauro Trevino stated that the Alamo Economic Development Center presented gift bags to the City Commisson and City Management that include some swag items and a "Shop in Alamo" shirt. He finished by congratulating the City for caring the AA-rating with standard and poor.

Public Comments

- Alex Cruz stated that he was there to speak on behalf of his parents Alejandro and Lorenza Cruz. His parents had a missing cat that has been located and it was found in a decommissioned irrigation pipe. He is requesting help to get the cat out of the pipe.
- Gabriel Aguilar congratulated the City Commission for their hard work and dedication.

Commissioner Roel Leon Moreno Jr. Motioned to approve Consent Agenda items 1, 2, 3, 4, 5, 6, 7, 8 and 9, Commissioner Pete Morales seconded. Motion carried.

III. Regular Agenda

D. Presentation of the 2023-2024 Audit for the Alamo Chamber of Commerce.

Mayor J.R. Garza stated that the City Commission had legal questions in regards to this item so they will further discuss it in Executive Session.

E. Consideration and Possible Action to select a contractor for Roof Renovations at Fire Station No. 2 and Alamo Youth Center Building.

Purchasing Agent, Adela Perez stated that The City solicited sealed proposals for professional contractors for the Roof Renovations at Fire Station No. 2 and Alamo Youth Center Building. The solicitation for services was advertised on September 18th & 25th with bid opening on October 8^{th} . 6 bids were received and evaluated by the City Staff and Project Architect Charlie Garcia:

Staff/used various criteria in determining the scores of the firms, cost, reputation, quality of goods, experience, and work done with the City of Alamo. This document outlines the bids received and the evaluation process. Staff's Recommendation: Approve award to Millennial General Contractors for \$187,357.00.

Commissioner Roel Leon Moreno Jr. asked whether the City provides a scope of work document when requesting bids.

Purchasing Agent Adela Perez respondes yes.

Mayor Pro Tem Okie Salinas asked Project Architech Charlie Garcia if everything was taken care of as per their last meeting.

Project Architech Charlie Garcia answered yes. When the pre bid package was put together, it included the recommendations and updates for these renovations.

Commissioner Roel Leon Moreno Jr asked if he has worked with this contractor before?

Charlie Garcia stated that while he hasn't worked directly with that contractor, he is familiar with the contractors they collaborate with and is confident in their ability to complete the work. Addittionaly they are using the manufactor that they recommended.

Mayor Pro Tem Okie Salinas asked if the Millenial General Contractors offered warranty?

Charlie Garcia answered yes, they offer manufactored warranty as well as craftman ship warranty as well at least one year with an option to go to two on both projects.

Mayor Pro Tem Okie Salinas asked since the buildings are old, were there significant changes in the materials that will now be used for the renovation.

Further was discussed in regards to the renovations.

Commissioner Roel Leon Moreno Jr. motioned to approve, Commissioner Pete Morales seconded. Motion carried.

F. Consideration and Action Regarding Advertising Proposals; De Shopping on Texas Magazine and Alamo Billboard Proposal.

City Manager Robert L. Salinas stated that the City of Alamo is seeking commission approval for the following advertising proposals to enhance city communication, visibility, and outreach efforts:

- 1. De Shopping on Texas Magazine Half or full Page ad
 - a. Half color page ad One Year contract:
 - i. Monthly Payment \$685
 - ii. Added Value:
 - 1. One post per month on Facebook and Instagram, reaching over 63,600 followers (\$50 value per month).
 - 2. One time use of a full page ad by combining two half-page spaces
 - 3. (proposed for Alamo's 100-Year Celebration).
 - 4. One time inclusion of a $\frac{1}{2}$ page editorial

- 2. Alamo Billboard Proposal Autopista Monterrey Reynosa
 - a. Location: Autopista Monterrey Reynosa (strategically positioned for high visibility).
 - b. One Year Contract
 - i. Monthly Payment \$650
 - ii. Includes one free vinyl and installation (\$600 value).

Staff recommendation: Staff recommends approval for the De Shopping on Texas Magazine half or full-page ad contract. This recommendation is based on the following:

- The added value provides increased visibility on digital platforms, which complements traditional print exposure.
- The flexibility to use ad space for key city initiatives, aligns with communication goals.
- Social media and editorial support provide a well-rounded advertising strategy.

Alternatively, staff also recommends consideration of the Alamo Billboard Proposal. The location provides valuable visibility to cross-border and regional travelers, with the added benefit of included setup costs. Both options offer value and alignment with the city's communication goals.

Mayor Pro Tem Okie Salinas suggested for the City of Alamo Hotels be promoted.

Commissioner Roel Leon Moreno Jr. motioned to approve half a page, Commissioner Pete Morales seconded. Motion carried.

G. Consideration and Action Regarding a Request to allow the Alamo Crimestoppers to use the Alamo Sports Complex for an event to be held on May 24, 2025.

City Manager Robert L. Salinas stated that a request was submitted by the Alamo Crime Stoppers for a baseball tournament to be held on May 24, 2025 at the Alamo Sports Complex. As per ordinance 85-11-22, the City Commission granted authority to the City Manager to authorize street closures and certain uses of city facilities, however I do not have the authority to waive the fees for the use of such facilities. According to the park code the rental fee for the Sports Complex for a non-profit user is \$75.00 per field, plus a \$100 deposit. The Crimestoppers are asking for the City Commission to waive the park use fee for their baseball tournament. Recommendation, since the event is a civic oriented event, and since the Crimestoppers are a non-profit entity, whose whole purpose is to raise funds to aid the Alamo Police Department, staff recommends approval of the waiver.

Alamo Police Officer Eddie Garza emphasized the need for at least two fields for their event, highlighting the large number of participating teams and requesting the fee be waived. He also detailed how the Alamo Crime Stoppers secure funding and utilize those resources to support their initiatives.

Mayor Pro Tem Okie Salinas motioned to approve the request, wave the fees and use all 4 fields, Commissioner AJ Garcia seconded. Motioned carried.
