I. CALL MEETING TO ORDER

Mayor J.R. Garza called the regular meeting held on Tuesday December 17th, 2024 to order at 6:00 p.m. at the City of Alamo Municipal Building. City Manager Robert L. Salinas led the Pledge of Allegiance and Commissioner Roel Leon Moreno Jr. led the Invocation.

Presentation and Announcements

- City Manager Robert L. Salinas stated that the City of Alamo will be closed on December 24th, 25th for Christmas and December 31st and 1st for New Years. Also December 23rd and December 30th offices will closed early at 3 P.M. He concluded by thanking all the City of Alamo Staff that participated at the Alamo's Christmas Parade and Tree Lighting.
- Commissioner Pete Morales thanked everyone who participated at the Alamo Christmas Parade and Tree Lighting including the PSJA ISD schools, residents and staff.
- Commissioner Roel Leon Moreno Jr. congratulated the PSJA Wildcats on their historic State Championship victory, marking the first time a team form the Rio Grande Valley has achieved this milestone.
- Mayor Pro-Tem Okie Salinas expressed that this meeting is the final City Commission meeting of 2024. He extended his warm wishes for a Merry Christmas and a Happy New Year and shared his enthusiasm for what lies ahead for the City of Alamo in the coming year.
- Commissioner Roel Leon Moreno Jr. wished a Happy Birthday to Commissioner AJ Garcia.
- Mayor J.R. Garza expressed his gratitude to everyone for an outstanding year, emphasizing the remarkable accomplishments achieved within such a short time frame. He continued expressing the entire City of Alamo staff for their contributions and support, acknowledging their accomplishments and efforts throughout the year.
- Commissioner Pete Morales invited the community to PSJA Memorial "Mean Girls" play taking place on December 19th, 20th and 21st.
- AEDC Consultant Isauro Trevino stated that on behalf of the AEDC he wanted to thank everyone for their continued support. He also stated that the new Taco Bell will be opening this upcoming Friday December 20th, 2024.
- Commissioner AJ Garcia recognized Mr. Espino and his family, as well as Ms. Flores Asnd Ms. Salas for attending the City Commission meeting.

- D. Consideration and Action to Approve a Proclamation Honoring Judge Ramon Garcia.

Mayor J.R. Garza read the Proclamation for Judge Ramon Garcia and declared December 17th, 2024 as "Ramon Garcia Day".

D. Consideration and Action to Appoint a City Secretary.

City Manager Robert L. Salinas stated that Assistant City Manager/City Secretary Alexandra Rangel submitted a resignation letter for the City Secretary position leaving the position available.

Commissioner AJ Garcia asked Assistant City Manager Alexandra Rangel and City Manager Robert L. Salinas, who would they recommend?

Both responded that Executive Assistant Ana Garza.

Mayor J.R. Garza motioned to appoint Ana Garza, Commissioner AJ Garcia seconded. Motion carried.

City Commission thanked Assistant City Manager Alexandra Rangel for her hard work and dedication and welcome Ana Garza to the City Secretary appointment.

E. Consideration and Action to Select a Contractor for the Water Treatment Plant Clarifier Rehabilitation Project.

City Manager Robert L. Salinas stated that the The City of Alamo solicited requests for sealed bids from professional contractors for the rehabilitation project. The City of Alamo advertised and requested the sealed bids on both November 6th and 13th with the bid opening on December 5th. The bids were received and reviewed by the project engineer. The results are as follows:

Javier Garcia, Project Engineer, reviewed the bids and verified with references of the firms, including experience, expertise of the firm, etc. – see attached recommendation letter. **Recommendation:** Staff recommends RGV Industrial Machine Shop and Pumps, LLC. This item is now before you.

Mayor Pro-Tem Okie Salinas motioned to approve, Commissioner Pete Morales seconded. Motioned carried.

F. Consideration and Action to Select an Engineer(s) to Provide Civil Engineering Services for the City of Alamo.

Commissioner Roel Leon Moreno stated that he has legal questions and he would like to move this item to Executive Session.

G. Consideration and Action to Appoint/Re-Appoint Members for the Alamo Economic Development Corporation.

AEDC Consultant isauro Trevino stated that the Alamo EDC has three board members whose terms are set to expire this month. Each of these individuals has expressed their willingness to continue serving in their respective roles. Reappointing Mr. Jose L. Garza, Mr. Alonzo Garza, and Mr. Albert Rodriguez will ensure the continuation of the remarkable progress and achievements accomplished under their leadership. Their dedication, experience, and unwavering commitment

to advocating for our vibrant community are truly invaluable. We kindly seek approval for their reappointments to maintain this momentum and continue supporting Alamo's growth and success.

Mayor J.R. Garza motioned to reappoint Mr. Jose L. Garza, Mr. Alonzo Garza, and Mr. Albert Rodriguez, Commissioner Roel Leon Moreno Jr. seconded. Motion carried.

Public Hearing

Consideration and Possible Action on an Ordinance to Rezone the West 5 Acres of Lot 10, Block 32, Alamo Land and Sugar Company's Subdivision; FROM R-2 Multi-Family Residential District TO R-1T Townhouse Residential District; Applicant: XLH Investments, LLC

Planning Director Sergio Zavala stated the following;

- The site is ¼ mile east of Cesar Chavez Road, along the south side of Ridge Road.
- The property's dimensions are $165' \times 1250'$ (approx.). FYI the proposed development is undergoing the subdivision review process (at the staff level at this time).
- Surrounding zonings include the following:

North R-1

South not zoned (Co. of Hidalgo)

East R-1 and R-2

West R-1

- Future Land Use Map FLUM) designation: High Density Residential (HD)
- Land uses include the following:

North one SF Residence

South Vacant

East Vacant & Apts. (1 lot width to E)

West SF Res/vacant

• To the east, beyond an intervening vacant tract, are the McKeever apartments. The desired R-1T zone is also within the land use parameters of the envisioned HD designation. Finally, the vacant tract that abuts it to the east will likely be converted to R-2 in the future.

Staff recommends approval. Planning and Zoning Commission Meeting: December 11, 2024 approved by unanimous vote.

Mayor Pro Tem Okie Salinas asked if the applicant had any visual aids of what they are proposing?

H. Consideration and Possible Action on an Ordinance to Rezone the West 5 Acres of Lot 10, Block 32, Alamo Land and Sugar Company's Subdivision; FROM R-2 Multi-Family Residential District TO R-IT Townhouse Residential District; Applicant: XLH Investments, LLC.

Commissioner Roel Leon Moreno Jr. motioned to approve, Commissioner AJ Garcia seconded. Motion carried.

Commissioner Pete Morales asked City Manager Robert L. Salinas if when developers request rezoning, do they ever bring visual aids to put in our website or social media?

City Manager Robert L. Salinas answered that when considering rezoning, they typically avoid using pictures to ensure the decision is based solely on the merit of the rezoning itself. He added that developers sometimes change their plans, and relying on images can create unrealistic expectations.

I. Consideration and Possible Action to Appoint one Member to fill a vacancy on the Traffic Safety Committee (TSC).

Planning Director Sergio Zavala stated that on January 2, 2024, the Board of Commissioners appointed 5 citizens to serve on the Traffic Safety Committee; one of whom was Rick Wright who served as the Traffic Safety Committee Chairman. Mr. Wright informed Planning and the Traffic Safety Committee at our December 2nd meeting that he was going to resign from the Traffic Safety Committee since he was moving to McAllen; he is in McAllen by the time of this meeting. Article 1 (B) of Traffic Safety Committee's Bylaws states that members "shall be residents of the City of Alamo, and be qualified electors at the time of their appointment." Mr. Wright's inaugural Traffic Safety Committee tenure was set to expire on Dec. 31, 2027; thus, any replacement shall have their enabled term end on 12-31-27, too. At this time, Staff requests the Board of Commissioners to appoint a resident that's a qualified elector as a replacement Traffic Safety Committee member. Staff's Recommendation: Appointment made to fill Traffic Safety Committee vacancy.

Commissioner AJ Garcia motioned to Appoint Michael Venedetti, Mayor Pro Tem Okie Salinas seconded. Motion carried.
