City Manager Robert L. Salinas stated that this is the approval of the contract of the above mentioned item.

F. Consideration and Action to award a bid for the City of Alamo Welcome Sign Project on IH2 and FM 907.

Assistant City Manager Alexandra Rangel stated that on February 20th, 2024 both monument agreements with TXDOT and designed was approved by the City Commission. We advertised on October 30th & Nov 6th (no bids received) and again on November 20th & November 27th; we did not receive any bids the second time around. Both myself and Purchasing Agent Ms. Adela Perez reached out to Buy Board, TIPS, and HUB contractors. Two quotes as follow:

We are happy to announce, if passed, we will be the first city in the region with a fully custom LED face-lighted and halo-lighted wall signs on the expressway. Staff's Recommendation: Award Noble Construction

Commissioner Okie Salinas asked what would be the time frame for the project to be completed?

Asistant City Manager Alexandra Rangel answered that if weather permiting, 2 months.

Commissioner Pete Morales motioned to approve, Mayor Pro-Tem Roel Leon Moreno Jr. seconded. Motion carried.

G. Consideration and Action to Approve a Contractor for the Morningside South Water Improvements Project.

City Manager Robert L. Salinas stated that the Urban County Program held a bid opening for the City of Alamo's Morningside South Water Improvements Project.

There were a total of 8 bids submitted as follows:

Based on the bid amounts the lowest responsible bidder is "The 5125 Company". 5125 is the company that is currently working on the sewer installation for the subdivision. They know the area well and are very capable of handling the construction of these waterlines and fire hydrants.

Urban County Program allocated \$265,071 for this project, leaving a balance of \$168,262. The City of Alamo has some UCP funds in the amount of \$74,338.78 that can be moved to help pay off some of this amount, but it still leaves a remaining balance of \$93,923.22 left to be paid by the City. Recommendation: Staff recommends the selection of "The 5125 Company" and the approval to use City funds (Reserves, ARP A, etc.) in order to complete this much needed construction. This item is now before you.

Commissioner Pete Morales asked if this was an accurate quote?

City Manager Robert L. Salinas explained that project engineers are responsible for inspecting various utility lines and existing infrasture. However, if any issues arise, they must be addressed by management. He noted that while they assume and hope everything is in order, Public Works must review and approve the work. Minor issues such as faulty valve, are possible but we cannot be certain.

Mayor Pro-Tem Roel Leon Moreno Jr. motioned to approve, Commissioner Pete Morales seconded. Motion carried.

H. Consideration and Possible Action to award bid for Hot Mix Asphalt Paving Materials for street overlays.

Purchasing Agent Adela Perez stated that the city solicited sealed proposals for the purchase of 1800 Tons of Hot Mix Asphalt. The solicitation for services was advertised on January 8th & 15th with bid opening on January 23rd, 2025. 4 Bids were received and reviewed by staff with the specifications outlined in the bid documents:

Public Works Director Julio Villarreal Jr. responded yes.

Commissioner Okie Salinas asked if there was a plan on which streets were going to be paved.

Public Works Director Julio Villarreal responded Bowie Street and Acacia Street.

Commissioner Okie Salinas requested to make a list of the streets that need paving.

Commissioner Okie Salinas motioned to approve, Mayor Pro-Tem Okie Salinas seconded. Motion carried.

Museum Director Alex Oyoque stated that he received 3 bids to finish phase II of the restoration for the Musuem. He recomends Lerma Construction to finsih the job because he was the lowest bidder and is offering to finish anything else that might need fixing.
