PUBLIC HEARING

D. TXDOT 2025 Transportation Alternatives Call for Projects as it relates to the "Alamo Kids Safety First Grant 2025 Project" for the Citywide Sidewalk Improvements.

AEDC Consultant Isauro Trevino stated that the City of Alamo TxDOT Sidewalk Grant Phase I consists of proposing a sidewalk in twelve different locations within the city. This project consists of a six-foot sidewalk, curb, ramps, and cross walk markings. The following sidewalk locations are as follows;

- Hackberry Ave. 3,900 linear feet
- Jasmine Ave. 1,240 linear feet
- Duranta Ave. 1,250 linear feet
- N. 10th St. 1,240 linear feet
- N. 13th St. 680 linear feet
- N. 7th St. 1,250 linear feet
- N. 8th St. 1,250 linear feet
- N. 9th St. 1,250 linear feet
- Nebraska Rd. 5,200 linear feet
- S. Alamo Rd. 640 linear feet
- Stensbo Ave. 360 linear feet
- W. Crockett 3,880 linear feet

The probable construction cost is \$1,451,741.04. Over 22 thousand of linear square feet for the City of Alamo, rouphly 4.2 miles. The reason we are holding this public hearing is because it allows us to earn additional points for community outreach and public involvement, which strengths our application. Public Participation in the Survey Monkey has been strong, and we received a great number of responses so far. We look forward to even more residents taking part and sharing their input. This survey will help with the grant application as well.

Mayor J.R. Garza stated that he is in favor of this city-wide sidewalk improvement project, emphasizing that it is greatly needed in our community and would significantly enhance the safety of students and children who walk along the roads.

Commissioner AJ Garcia stated that it is very important that we bring the City of Alamo to a better healthy life style. Walking will improve the health of the residents.

Mayor Pro-Tem Roel Leon Moreno Jr. stated that it is important for all of the City of Alamo constituants to practice safety in every aspect of their lives. Practicing healthy habits is important.

Commissioner Okie Salinas stated of the record that he completely supports this project. He would like to suggest for the map to have the excisting sidewalks for future reference.

Commissioner Pete Morales stated that he totally supports this project specially sidewalks around schools for benefting all the children who walk to school.

E. Consideration and Action to Approve a Resolution supporting the City of Alamo Application to the Texas Department of Transportation's 2025 Transportation Alternatives Set-Aside (TA) call for projects.

Commissioner AJ Garcia motioned to approve, Mayor Pro-Tem Roel Leon Moreno Jr. seconded. Motion caried.

F. Consideration and Action regarding a 380 agreement payment to AMMO Development.

City Manager Robert L. Salinas stated that on July 14, 2022, the City of Alamo entered into a 380 agreement with AMMO Development. The Company will complete between 25%-40% of the residential units, completing meaning lot and apartments would be completed within 36 months of the agreement. The city received a request for payment of \$200,000 based on this completion. After a review of the permits that have been issued and completed regarding the apartments, it has been confirmed that a minimum of 25% have been completed and finalized, thus allowing for the release of payment. Recommendation: Staff recommends approval of the release of payment of \$200,000 as per the agreement requirements. This item is now before you.

Mayor Pro-Tem Roel Leon Moreno Jr. motioned to approve, Commissioner Pete Morales seconded. Motion carried.
